Abstract Submission Guidelines and Formatting Sample

- 1. The participants' abstracts should be presented in MS Word format, typed within the two-page limit, page size A4, exclusive of figures, tables and graphs. The font of the body of the text and the references should be size 12, Times New Roman, black. The paragraphs should have single spacing, full justification, 1 cm indention. The paper should have 2 cm margins on all sides.
- 1. Abstract header should be centered in the first line, uppercase, bold, size 14 (without indention). The author's (co-authors') surname(s) and initials should be centered in the line below, single spacing (lowercase letters, in italics). Please center the affiliation in the line below: the city, the country (italicized). The main text should be typed below, single line spacing.
- 1. The body of the text (full justification) should contain information and the authors' own factual material on the designated topic; the text should be divided into sections: introduction, objective of the paper, material and methods of the research, results, discussion, findings (conclusions). The title of the section should be in bold, highlighted. Reviews are not accepted for publication.
- 1. Mathematical formulas, tables and figures are generally acceptable in the body of the text. Graphic materials should be inserted into the text. All the figures and tables should be displayed with a title and referenced in the text. If there are several figures and tables, they should be numbered. Please number basic formulas only. Enclose the number of a formula in the parentheses and position it rightmost in the line. All the references should be enclosed in square brackets in the text.
- 1. The abstracts should be followed by the reference list, centered, single spacing. The "Reference List" subtitle should be centered without indention, highlighted, in bold. The reference list entries should be assigned a number and arranged by citation order. The reference list should contain the following: the author's (authors') surname and initials, the title of the paper, the title of the journal or collected papers (for articles), the city and full name of the publishing house (for monographs), year of publication, volume, journal issue and pages. The author's (authors') surname and initials within an entry (or the first word in the title of a book) should be italicized.
